1. Balloting will be used to determine the order of priority and the balloting will be performed by computer. Only individuals are permitted to participate in the balloting procedures.

2. Company purchaser(s) shall not be entitled to submit Registration of Intent nor purchase the specified residential properties listed in this Sales Arrangements. The restriction applies to the first date of sale and thereafter.

The order of the submission of a Registration of Intent will not have any impact on the order of priority in selecting the specified residential properties.

- (i) The balloting will take place on 17 July 2016 not earlier than 10:00 a.m. at Sales Office 1. All registrants are welcome to view the balloting. The Vendor reserves the right at any time, for the purposes of maintaining order at Sales Office 1 and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting. Any changes to the time and date of the balloting will be posted at Sales Office 2. Registrants will not be notified separately of such changes.

- (ii) For the purpose of verification of identity, each registrant must bring along his/her original H.K.I.D. Card(s)/Passport(s) and the original receipt of the Registration of Intent and personally attend the lobby on the G/F of Regal Hongkong Hotel, 88 Yee Wo Street, Causeway Bay, Hong Kong (the “**check-in counter**”) from 8:30 a.m. to 10:00 a.m. (“**check-in timeslot**”). Registrants shall only be eligible for the balloting after the verification of identity and the registrants of each registration shall be entitled to only one lot. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the basement, lobby on G/F and 1/F of Regal Hongkong Hotel, 88 Yee Wo Street, Causeway Bay, Hong Kong (collectively the “**Additional Venues**”) to accommodate some of the registrants by making appropriate announcement(s) at Sales Office 1 and the Additional Venues to direct registrants to the Additional Venues. Registrants who arrive at the check-in counter beyond the check-in timeslot shall not be eligible to participate in the balloting.

The Vendor reserves its absolute discretion to allow or reject the registrant to add any person(s) to sign the Preliminary Agreement for Sale and Purchase.

Registrants will not be notified separately of the arrangements.
