1. Registration of Intent will be distributed from 10:30 a.m. to 11:00 a.m. (the “Attendance Registration Period”) at Sales Office 1 on the First Date of Sales. Persons interested in purchasing any of the specified residential property must personally attend Sales Office 1 and submit:

The Registrant shall indicate which specified residential property that he/she wishes to purchase in the Registration of Intent. Each Registrant (whether in his/her sole name or jointly with any other person) may only submit (a) not more than two Registrations of Intent; and (b) one Registration for each specified residential property that he/she wishes to purchase. Late submission or duplicate registration will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferrable.
